

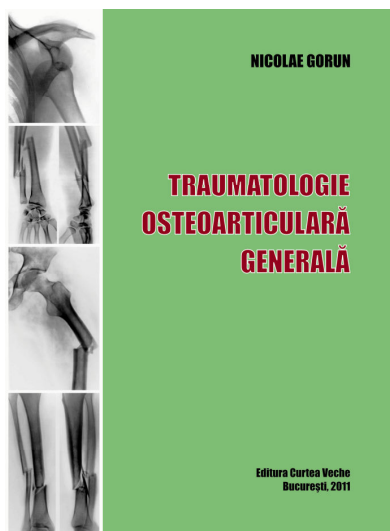
New medical books

“TRAUMATOLOGIE OSTEOARTICULARĂ GENERALĂ”

Periodic emergence of new and new treaties in Orthopaedics and Traumatology, signed by N. Gorun no longer a surprise to anyone. Orthopedics and traumatology data bank recently became richer, accumulating one new monograph titled, *Traumatologie osteoarticulară generală* published by Publishing House "Curtea Veche". This monograph is the effect of great tenacity and strength of professor, who was put in the service of medical science. It is at the same time, the result of continuous training, started in college and continued until today, as recorded in volume of Radu Nicolae "Memory resurrected", where the teacher Gorun was described as "customary in the library, the last one leaving after midnight".

I do not know another person in the medical field with a scientific production of books, publications and communications higher than his.

The contents of this volume creates attraction for residents, young professionals and even senior physicians with experience, willing to know the methods of safe and effective treatment. Bibliographic documentation is impressive. Articles are cited in each chapter, totaling over 1,300 bibliographic titles.

First chapter contains unique, concise and revealing moments in the history of osteoarticular traumatology, richly illustrated with photographs of medical personnel who have contributed to the development of this specialty. All scientific events have had the Professor present and many of his books were released there.

The doctor who endorses the concepts given in the first five chapters has the chance to become a competent practitioner that read to the smallest details, with the basic theory - fundamental criterion of truth in practice.

In Chapter 6, entitled traumatic dislocations, indispensable notions are resumed for medical practice, which helps avoid serious complications that can invalidate the patient.

Although methods of treatment are controversial, the topic being the subject of many congresses and conferences, national and international, the author succeeds with lucidity and experience to set light to most effective therapeutic protocol, adapted to each clinical forms part.

Chapter 7, for the wound, worth rightly a particular attention, given the possible consequences devastating of wounds healed per second or per third may have in orthopedics. Apparently unimportant for ignorant, this chapter details to the doctor meticulously recorded data, put him away from possible repercussions (forensic) and give certainty to acts of postoperative care, allowing wound healing, especially in laborious surgery.

Chapter 8 – Fractures, are recorded in more than 230 pages, cvasihaustiv essentials of traumatic pathology of the skeleton. In this chapter, radiological knowledge and clinical data support the diagnosis certain, especially pathological fractures.

In the last chapter, the author treats in his style well known, incidents and complications of metallic osteosynthesis, showing a force of orthopedics and traumatology of uncontested master, acquired in decades of experience.

All recorded on the treaty impose on Mr. Prof. Univ. Dr. Nicolae Gorun as distinct personality in the world scientific Romania, worthy of respect and appreciation.
